The Court's lack of timely response and the continuation of some Court official's Cover-up for enablers of a foreign terrorist regime and the Islamic Revolutionary Guard Corps (IRGC)

On March 20, 2023, in a letter "*RE: Unlawful Conduct of the Registry undermining the basic rights of the appellant in this appeal*", I brought to your attention the ongoing illegal intervention by Tim Outerbridge and his assistant, Littlejohn, clearly favouring the enablers of foreign terrorists within Simon Fraser University. Yet, I have not received any response from the Court about this intervention, particularly as to a purported stay of my appeal "pending" a determination by the Division- as Littlejohn claims. Doubling down on that legally baseless and obviously false claim about the stay of the appeal, the Registry has gone on to refuse to file my application whereby I am seeking to (1) halt the embarrassingly crafty intervention of Outerbridge and (2) set aside Outerbridge's previous "directions" in this matter, including his asking the Division for summary dismissal of my appeal, which is apparently to appease the politically and financially super-powerful enablers of an Islamic terrorist regime in British Columbian academia.

As you are aware, this appeal has been brought to address the issue with the bias of Judge Fitzpatrick of the court below.

Since a portion of my forthcoming supporting evidence concerns the way Fitzpatrick's biased conduct in a jurisdictional challenge has led to further character assassination of the plaintiff by other apologists of the Islamic terrorist regime ruling Iran, particularly those affiliated with the influential lobbyist Karim Aga Khan, I would like to bring your attention to a recent judgment of the court below in *Masjoody v. Burnaby Beacon*, 2023 BCSC 528, containing the defendants' admission in open court that their defamatory publications against the plaintiff were motivated by Fitzpatrick's shockingly biased, unethical, and unprofessional low-level essay that she published as her "Reasons for Judgment". Further in that regard and having reviewed some other instances of controversial conduct by Fitzpatrick in other matters, it appears that this judge has frequently been tasked with adjudicating "inconvenient" legal matters and dealing with

them in such a biased way that decent judges would not be expected to. One of the latest of these instances is Fitzpatrick's decision in *Trans Mountain Pipeline ULC v Mivasair*, 2023 BCSC 410, which is under appeal on several grounds including, as one should expect, the bias of the judge, in that the appellant is seeking to "challenge ... the unfair and unjust sentences that have been the bread and butter of Fitzpatrick's long and storied career protecting corporate interests against the health and well being of Indigenous and Black communities."

These provide further reasons why the Division should not yield to extrajudicial pressure from in and out of the Court aiming to continue the cover-up scheme for the enablers of the Islamic terrorists and for a judge of a lower court who apparently acted within that scheme. Any effort to keep Fitzpatrick's bias under the rug is not only wrong but also bound to fail given the growing public awareness about her frequently biased conduct over her career. It is certainly not a good deal to continue to turn a blind eye to a lower court judge's embarrassingly biased conduct at the cost of causing wholesome embarrassment for an upper court and, effectively, the entire justice system in Canada.

As noted in previous correspondence with the Court, the interference of the regime of the Islamic Republic and its enablers in British Columbian academia and justice system have been addressed in my letters to the MPs, all of whom have a duty to take foreign interference seriously, as many of them have. In particular, I find it worthwhile to share with the Division the attached communications of mine with the Office of the Prime Minister and the Minister of Public Safety, to whom the matter had been referred by the Prime Minister's office. (My latest appended communication herein is a partially redacted copy of a letter dated April 11, 2023, marking the fiftieth day of my ongoing hunger strike for justice, of which the Court was formally informed on Feb 16, 2023.)

RE: Interference of the regime of the I.R. of Iran in the justice system via enablers in British Columbian academia and courts

Greetings,

While foreign interference by Putin's regime and the Chinese Communist Party is finally getting the proper attention of the public and politicians, the prominently rising illegal activities of the Islamic Republic of Iran (particularly through members and affiliates of the Islamic Revolutionary Guard Corps (IRGC)) in the form of espionage, infiltrating the academia and research labs, buying influence in the public and private sectors, raising funds for terrorist groups, money laundering, drug trafficking, etc. are mostly ignored despite occasional verbal acknowledgement from the highest level of the political arena in Canada.

In the attached material, I am copying a letter of this March 13, 2023, to the Chief Justice of BC regarding the unprecedented irregularities in courts and misconduct of court officials in a matter concerning the agents of the Islamic Republic who were supported and protected by Simon Fraser University.

My legal action against SFU is for the university's expansive campaign against me in retribution for the disclosure of their ties and support for **the ballistic missiles expert Shahrokh Jam** and other agents of the I.R. closely **tied with Ali Khamenei, IRGC, and the current Islamic president Ebrahim Raisi**.

The matter in dispute and the gravely concerning fashion the BC court officials have so far dealt with it must be alarming to any learned statesperson, as they exemplify the level of protection the agents of the I.R. have been directly or indirectly receiving in two of the most important institutions, i.e. the academia and the justice system.

It is this sort of protection that has regrettably made Canada the number-one destination of the I.R. agents for the above-mentioned illegal activities all of which are ultimately in support of the state terrorism by the current rulers of Iran.

As long as the terrorist entity IRGC is not listed as such under the Criminal Code and interference of the I.R. is not meaningfully counteracted, it is expected that this embarrassing situation for the courts and academia in BC will only expand to other provinces and the contaminated institutions will become a higher risk to the national and international security.

RE: Interference of the regime of the Islamic Republic in the Government's investigations about the regime; and the exemplary influence of the regime's agent in Canada [REDACTED]

Firstly, I would like to profusely thank you for taking up this matter of **foreign interference in academia and the justice system of British Columbia**, which, as the office of the Prime Minister has rightfully identified, concerns matters relating to Canada's public safety at large.

I will proceed by providing a brief summary of my previous communications: Four years ago today, on 11 April 2019, I sent my report to the president of *Simon Fraser University* about the activities of some agents of the *Islamic Republic*, including **the ballistic missiles expert Shahrokh Jam**, among others all tied with the terrorist *IRGC* and the two highest authorities of the Islamic Republic. *SFU* reacted to the report by completely diverting the issue and not only withheld my report from the intelligence community but blatantly launched vengeful campaigns against the whistleblower. In April 2020, I commenced legal action against *SFU*. From that point on, collusion between *SFU* and the courts and a set of severe misconducts by public servants in the justice system emerged which aimed at covering up for terrorists and their enablers; and continue to be indicative of the extensive interference of the *Islamic Republic* in Canada ranging from academia through deep into the justice system.

As acknowledged also by Prime Minister *Trudeau*, the foreign interference of the *Islamic Republic* in Canada prominently relies on illicit operations of the *IRGC* in finance, espionage, and buying access to politicians and decision-makers. All of these operations are eventually in support of the terrorist activities of the *IRGC*, an organization which the Prime Minister has personally called terrorist but astonishingly refuses to list as a terrorist entity under the Anti-terrorism Act.

Accordingly, one must admit that the Government's lack of proper action against the *IRGC* is the root cause of the national embarrassments an example of which we have been witnessing in British Columbian courts and academia.

Indeed, based on my direct knowledge and experience on similar occasions, I am particularly concerned that agents and apologists of the regime may undermine the Ministry's investigation into the current matter simply by activating any of their existing links to the Government of Canada. For instance, I have direct knowledge of a similar situation concerning the influence of a top Iranian-Canadian agent of the *Islamic Republic*, where the intelligence community seems to have been instructed to not investigate the matter. In that case, the agent [REDACTED] was reported in Feb 2022, to both CSIS and INSET [REDACTED] but neither institution reached out for supporting documents and other forms of available evidence [REDACTED] is still acting as a de facto top diplomat of the *Islamic Republic* in Canada while normalizing that blood-thirsty regime and actively helping the regime bypass the international sanctions.

Despite an abundance of troubling public information and several intelligence reports, [REDACTED] has even broadened his access to the upper echelon of power within the Government and the ***Liberal Party of Canada*** alike. Compelling evidence [REDACTED] shows that he, in the guise of a private Canadian businessman, has been actively helping the *Islamic Republic* bypass international sanctions during his presence in Latin American countries and Mexico. There are also reports and learned witnesses of his attendance at a recent **NATO** session with the support of Canadian authorities.

I am appending a copy of the information about [REDACTED] shared with the INSET more than a year ago on [REDACTED] 2022. As this letter may become a public record, I am excluding the names of the learned officers.

To conclude, I would like to briefly bring up the existence of a related set of facts about the involvement of another Canadian entity, besides courts and SFU, that seemingly out of nowhere got actively involved in supporting the enablers of terrorists who were the subject of my legal action. The affiliation of that entity with **Karim Aga Khan**, given the latter's own connections with the *Islamic Republic* and his longstanding and ongoing influence on the top Government officials, makes it worthy of consideration in so far as hindering or undermining the Government's sincere efforts in unravelling the elements of the very interference in question is concerned.

The information delivered to the INSET on [REDACTED] 2022

"I would like to share with the INSET some information about part of the ongoing activities of an Ottawa-based former affiliate of the Embassy of the Islamic Republic ("IR") [REDACTED]

[REDACTED] I shared with CSIS Vancouver some of the information included herein that was known to me at the time. I have the knowledge or possession of supporting evidence for the information shared herein. Part of the evidence includes publicly available content on the internet.

Short Background:

[REDACTED] was the director-general of [REDACTED] (until that [REDACTED] properties were seized pursuant to the Justice for Victims of Terrorism Act.) He was a director of the [REDACTED] all of whose members were closely tied with IR and its leadership. He is now the president of [REDACTED] *Muslim* [REDACTED] I skip the rest of the background information about [REDACTED] all of which I believe is known to the security intelligence communities. However, I would like to point out that in support of the Islamic Republic, [REDACTED] actively collaborates with other individual and organizational lobbyists and supporters of IR, such as the Vancouver-based [REDACTED] and some of its directors.

Here, I focus on [REDACTED] trip to Iran.

He has been in Iran since [REDACTED] 2022. He flew to Iran from Qatar, where he was on a diplomatic mission on behalf of the IR. In Iran, he attended at least two meetings in the Ministry of Foreign Affairs ("MFA") in [REDACTED] and was the main speaker of another event in the MFA held on [REDACTED] 2022.

[REDACTED] meetings with the members of MFA are focused mainly on resuming the diplomatic and (higher-level) economic relations between Canada and IR through (in his words and referring to the shooting down of PS752) "resolving the difficulties arising from the aircraft issue."

He has had numerous meetings with members of different Chambers of Commerce in Iran, including but not limited to the Iran-Canada Chamber of Commerce and Tehran Chamber of Commerce. [REDACTED] at the Tehran Chamber of Commerce.

Through these meetings and speeches, he's been discussing how to bypass economic sanctions against IR through trade partners in Canada and Latin America, particularly in Brazil, Ecuador, Columbia, and Chile.

[REDACTED] is expected to return to Canada in [REDACTED]
