ON THE APPLICATION of Masood Masjoody, the Plaintiff without notice coming on for hearing at Vancouver Courthouse, 800 Smithe Street, Vancouver, BC on 17/Sep/2024 and on hearing Masood Masjoody, the Plaintiff;

THIS COURT ORDERS that:

1. The Defendants John Doe 1 ('JD1'), John Doe 3 ('JD3'), John Doe 6 ('JD6'), and John Doe 7 ('JD7') are prohibited from publishing, causing to be published, or disseminating, whether directly or indirectly, any defamatory statements, comments, or materials concerning the Plaintiff, Masood Masjoody, pending the final determination of this action or further order of this Court.

- The Defendant JD1, within 3 days of service of this Order in the manner required by the order issued on June 27, 2024, by Madam Justice Warren, must remove any and all statements, posts, comments, or materials about the Plaintiff, Masood Masjoody, made by JD1 from the Internet, including but not limited to:
 - (a) Set 2, as identified in the Amended Notice of Civil Claim, filed March 22, 2024 ("ANoCC");
 - (b) Set 3, as identified in the ANoCC and Schedule A of this order ("Schedule A");
 - (c) Set 11, as identified in the ANoCC and Schedule A;
 - (d) JD#1Post#1, as identified in Schedule A;
 - (e) JD#1Post#2, as identified in Schedule A;
 - (f) JD#1Post#3, as identified in Schedule A;
 - (g) JD#1Post#4, as identified in Schedule A.
- 3. The Defendant JD3, within 3 days of service of this Order, must remove any and all statements, posts, comments, or materials about the Plaintiff, Masood Masjoody, made by JD3 from the Internet, including but not limited to:
 - (a) Set 6, as identified in the ANoCC and Schedule A;
 - (b) Set 12, as identified in the ANoCC and Schedule A;
 - (c) Set 13, as identified in the ANoCC and Schedule A;
 - (d) Set 14, as identified in the ANoCC and Schedule A;
 - (e) Set 15, as identified in the ANoCC and Schedule A;
 - (f) JD#3Post#1, as identified in Schedule A.
- 4. The Defendant JD6, within 3 days of service of this Order, must remove any and all statements, posts, comments, or materials about the Plaintiff, Masood Masjoody, made by JD6 from the Internet, including but not limited to:
 - (a) JD#6Post#1, as identified in Schedule A;
 - (b) JD#6Post#2, as identified in Schedule A;
 - (c) JD#6Post#3, as identified in Schedule A;
 - (d) JD#6Post#4, as identified in Schedule A.

- The Defendant JD7, within 3 days of service of this Order, must remove any and all statements, posts, comments, or materials about the Plaintiff, Masood Masjoody, made by JD7 from the Internet, including but not limited to:
 - (a) JD#7Post#1, as identified in Schedule A;
 - (b) JD#7Post#2, as identified in Schedule A.
- Pending further order of this Court, the Defendants JD1, JD3, JD6, and JD7 are prohibited from publishing, disseminating, or sharing, directly or indirectly, any further statements, comments, or materials relating to the Plaintiff, Masood Masjoody.
- 7. The Plaintiff is awarded costs of this application.
