ON THE APPLICATION of Dr. **Masood Masjoody**, the Plaintiff, without notice coming on for hearing at Vancouver on 09/Oct/2025; and on hearing Dr. **Masood Masjoody**, the Plaintiff, appearing on his own behalf;

THIS COURT ORDERS that:

1. The Plaintiff is permitted to use the alternative method of service referred to as "Posting on X (formerly Twitter)" described in part 2 below, to serve the defendants **John Doe #1, John Doe #3, John Doe #4, John Doe #6, and John Doe #7** (these "Defendants") with the following documents (these "Documents"):
 - a. the Further Amended Notice of Civil Claim, filed September 3, 2025; and
 - b. this entered order, dated September 19, 2025.
2. To serve each of these documents by Posting on X (formerly Twitter), the plaintiff is required to do the following:
 - a. **Upload these Documents:** Upload these documents to an online file managing service or the plaintiff's website, ensuring that the uploaded documents are publicly accessible on the Internet;

- b. **Prepare Advertisement:** Prepare the form attached to this order as Schedule A for posting on the website for X (formerly Twitter), at X.com, (the "Advertisement");
 - c. **Create Links:** Generate a link to each of the uploaded documents as indicated in the Advertisement, ensuring that they are publicly viewable and downloadable but not editable, (the "Links");
 - d. **Publish Service Post:** Publish a publicly accessible post on the plaintiff's account on X (formerly Twitter) having the handle @MasoodMasjoody, including the Advertisement with the Links and tagging these Defendants' X handles (the "Service Post");
 - e. **Maintain Accessibility:** Keep the Service Post publicly accessible on X (formerly Twitter) for at least 14 business days.
3. **Timeline for Response:** To calculate the timeline for filing a response to the Further Amended Notice of Civil Claim, filed September 3, 2025, and served by Posting on X (formerly Twitter), the service document is deemed to have been served on these Defendants in British Columbia 10 days after the Service Post is published on X (formerly Twitter).
