

## OPEN LETTER:

**To: The Honourable Pierre Poilievre, P.C., M.P.**

Re: February 9, 2024 Vancouver meet-and-greet — shutdown through intimidation, Hamas collaboration, access channels, and urgent preservation of records

### **Reza Pahlavi's network shut down your Vancouver event on February 9, 2024**

**Dear Mr. Poilievre,**

Records I recently obtained through a series of orders of the **Supreme Court of British Columbia** (the most recent granted on December 15, 2025) objectively establish that your Vancouver **Persian community meet-and-greet on February 9, 2024** was shut down by **Reza Pahlavi**'s networks.

I am writing this publicly because this represents a new level of atrocity by these networks. They are already notorious for coordinated attacks on Iranian pro-democracy activists, which is why they are before the Supreme Court of BC and why Reza Pahlavi faced two conclusive judgments against him on October 16, 2025. But shutting down the public event of a national political leader on the verge of elections in Canada is an escalation into direct interference with Canadian democratic life.

When a Canadian federal political leader like you can be forced out of a venue through intimidation—particularly if the same actors can penetrate political communities through relationship-based access while coordinating venue tracking, harassment, and intimidation with a designated terrorist entity and against the same communities—then Canada has a sovereignty and public-safety problem, which goes beyond any partisan boundaries.

On February 9, 2024, **Reza Pahlavi**'s networks acted through premeditated political intimidation orchestrated on the ground by two individuals: **Arezou Soltani of North Vancouver** and **Mehdi Ahmadzadeh of Maple Ridge**, who jointly led a local Pahlavi affiliated group registered in British Columbia as **Canadian Iranian Wakuppers Foundation** (the “Wakuppers”).

Those disclosed records from the Wakuppers' WhatsApp group chat show:

- real-time tracking of your appearance,
- active efforts to locate the venue while you were speaking,
- celebratory messaging after the shutdown, and

- **Mehdi Ahmadzadeh**'s own voice message, in which he vividly describes and boasts about assaults, pushing, intimidation and dragging the attendees "into dust and blood".

You remember that night. Barely seconds after you began your remarks at:

**True Confections Denman, 866 Denman St, Vancouver, BC V6G 2L9,**

the disruption started by Hamas supporters and the scene changed instantly. The event had been anticipated as roughly a 90-minute meet-and-greet. Instead, you were forced to cut your entire remarks down to roughly 15 minutes and escorted out by your security team early.

You also tried to defuse the disruption and offered a fair compromise—words to the effect of: "Let me give my remarks, and during Q&A you can ask your questions." They refused. You then called it out on the spot—"It seems we have the Iranian regime here," and referred to them as "**IRGC supporters**."

**You were right, but that was not the full reality.**

What happened that night was not just "IRGC people showed up." It was a coordinated operation involving collaboration between **IRGC-aligned Hamas supporters** on the ground and a local **Pahlavi network** behind the scenes, with **Soltani** and **Ahmadzadeh** operating as the on-the-ground masterminds.

What you did not know prior to reading this letter—and what I only fully understood lately following the Court-ordered disclosures—is that the shutdown was indeed orchestrated by the Pahlavi networks.

Here is the blunt truth: Out of expressed hostility, they handed the location to Hamas supporters, who then arrived and executed the shutdown. They were the visible shock-troops on the ground; the venue-locating and mobilization came from the Wakuppers led by the Pahlavi operatives, **Soltani** and **Ahmadzadeh**.

With all that said:

- It is striking that **Reza Pahlavi** had previously tried to portray himself publicly as a proponent of your political rise and access to the Iranian community, and that he met with you in or about March 2023. Yet the evidence now shows that local circles aligned with him were behind the disruption and shutdown of your February 9, 2024 event.
- It is also striking that the same local circle, namely, the Wakuppers, includes **Mary Hakimi**, the partner of **Doug Horne**, a former Conservative MLA—an obvious access channel into Conservative circles.

Through court-ordered production, I have also obtained a photograph showing **Arezou Soltani** and **Mehdi Ahmadzadeh** in close proximity to you. I am informed they obtained backstage access to you through the **Mary Hakimi / Doug Horne** connection.

Another matter you may not be aware of is that these same circles use **MEK-labelling** exactly the way the **Islamic Republic** does: as a weapon to intimidate, discredit, and socially isolate Iranian pro-democracy activists—and, when convenient, to smear Conservative politicians and MPs as well.

To that point, the Wakuppers' group chat content I obtained includes foul and contemptuous language directed at the **Conservative Party of Canada** and at senior Conservative figures, such as the **Right Honourable Stephen Harper**, including condemning the shutting down of the Islamic Republic's embassy and advancing pro-IRGC narratives, in the guise of the same MEK-labelling described above. Representative portions are included as appendices by way of certified translation.

I should say that all these records and relevant orders were obtained despite persistent efforts by **Soltani** and **Ahmadzadeh**—and their counsel, **Nojan Kamoosi**—to obstruct accountability and distort the process through false and misleading sworn materials. In my proceedings, I have had to confront multiple affidavits that were perjured and specifically designed by **Nojan Kamoosi** and his law firm to derail proper adjudication, prevent disclosure, and mislead the Court.

I assume your office will treat this new disclosure about the February 9, 2024 shutdown as a serious public-order and democratic-integrity concern, and will coordinate with the Vancouver Police Department (and any other appropriate agencies) to ensure that the relevant records are secured and reviewed.

I also formally request that your office take immediate steps to ensure the preservation of all relevant records relating to the February 9, 2024 shutdown, for the purpose of ongoing litigation, Action S-246401, against **Reza Pahlavi** and his network (including co-defendants **Soltani** and **Ahmadzadeh**, among others), which addresses their engagement in political violence and intimidation in Canada.

This preservation request includes, without limitation:

- security incident notes and internal reports;
- communications with organizers and any third-party intermediaries about the incident; and
- access logs and records relating to who facilitated **Soltani's** and **Ahmadzadeh's** backstage access to you on Feb 9, 2024; to the extent such records are within your control or can be preserved through timely requests to the relevant custodians.

For ease of review, I will provide the following appendices with this open letter:

- **Appendix E:** Photograph of Reza Pahlavi with the Honourables Pierre Poilievre and Melissa Lantsman (presumably taken in March 2023).




I mean they are outright  presumptuous, but for the time being, they don't dare to  raise their heads and repeat such improper actions.  Tomorrow, we'll give additional explanations.  Sorry, it's late now; we're tired. We'll go get some rest  so that in the morning we can go after the <b>MEK</b>—let's  see who wants to show up there.</p>

### **A. Background and purpose**

2. I make this affidavit to place in evidence the details of the **February 9, 2024** Persian community meet-and-greet involving **the Honourable Pierre Poilievre** in Vancouver, including **(a)** the initial venue information confirmed by the organizer, **(b)** the security-driven relocation after attendees gathered, **(c)** my Instagram livestream from the event, **(d)** the **Wakuppers group chat discussions** that occurred while I was livestreaming, including discussion of my Instagram Live and efforts within the chat to **locate the venue/restaurant**, **(e)** the **disruption on February 9, 2024 by individuals I understood to be Hamas supporters, which shut down the event**, and **(f)** further Wakuppers group chat messages after the shutdown, including remarks by **Arezou Soltani** and **Mehdi Ahmadzadeh celebrating** the “eventful night” and expressing satisfaction with the outcome, in a Wakuppers group chat that **they administered**.
3. Although I received the Wakuppers Native Chat Exports from Dr. Rosita Fatemi in late October 2025, the specific excerpts reproduced below—and their connection to the **February 9, 2024** shutdown of the Poilievre event and to my Instagram Livestream—only recently came to my attention in a material way as I reviewed the exports more closely in light of the developing timeline and issues in this proceeding.
4. I also make this affidavit to provide necessary background about my prior dealings with MP Marc Dalton and prior incidents involving Arezou Soltani and Mehdi Ahmadzadeh in connection with Vancouver Woman–Life–Freedom events.

### **B. Event confirmation and initial venue**

5. The event details and initial location for the **“Persian Community Meet and Greet with Pierre Poilievre”** are set out in a registration confirmation email I received from Conservative Party of Canada Events ([events@conservative.ca](mailto:events@conservative.ca)), showing that the event was scheduled for Friday, February 9, 2024, with doors open at 6:45 PM, and the initial venue listed as Khagan Restaurant, 851 Denman St, Vancouver, BC V6G 2L9, with the event ending around 8:15 PM.

### **C. Attendance and relocation by security to True Confections**

6. On February 9, 2024, I attended the event area at the location stated above.
7. After attendees gathered at or near Khagan Restaurant, members of Mr. Poilievre's security team directed that the meeting location be changed to **True Confections Denman**, 866 Denman St, Vancouver, BC V6G 2L9, which is directly opposite Khagan Restaurant.
8. This direction was communicated at the scene after people had already assembled, and it resulted in attendees moving from the initial venue to True Confections across the street. I understood the relocation described above to have been made for security reasons, given that it was directed by security personnel and occurred after the crowd gathered.

**D. MP Marc Dalton at the relocated venue and prior relationship**

9. After the relocation to True Confections Denman on February 9, 2024, I saw Member of Parliament Marc Dalton, who was accompanying Mr. Poilievre at the event.
10. I recognized Mr. Dalton because I have known him since 2021, when I first met him personally.
11. Since 2021, I have met Mr. Dalton in person on several occasions, including to debrief him regarding matters of public importance such as my advocacy concerning the **terrorist designation of the IRGC**, the **PS-752 matter** (the shooting down of Ukraine International Airlines Flight PS-752 by the IRGC), related or prospective legal proceedings in Canada arising from that incident, and **foreign interference** in Canada by the Islamic Republic ruling Iran.

**E. Prior involvement with Woman–Life–Freedom events and Wakuppers opposition to Mr. Dalton (2022–2023)**

12. I also have prior familiarity with Mr. Dalton's public engagement with the Iranian-Canadian community in Vancouver in connection with Woman–Life–Freedom events.
13. In 2022, following the killing of Mahsa Amini by the morality police of the Islamic Republic, a Woman–Life–Freedom rally took place in Vancouver at which Mr. Pierre Poilievre attended and spoke, and Mr. Dalton also attended. The invitation and arrangements of Mr. Poilievre's attendance and speech at that rally were facilitated

with the assistance of Mr. Dalton and a friend of mine who is close to Mr. Dalton's office. Mr. Dalton assisted in securing and supporting a positive response to the invitation.

14. I also assisted in facilitating Mr. Poilievre's attendance and speech at that rally by coordinating with different factions within the Iranian diaspora whose internal disagreements, in my view, created a real risk that the appearance could be cancelled or disrupted. The appearance ultimately went ahead.

15. In or about September 2023, I invited Mr. Dalton to speak at a Mahsa Day rally in Vancouver set to be held on September 16, 2023.

16. I recall that, despite general agreement among organizers that Mr. Dalton would attend and speak, **Arezou Soltani** began advocating that Mr. Dalton's participation be cancelled, including by alleging that Mr. Dalton was an "**MEK agent**" and by making accusations characterizing the MEK as a terrorist organization in Canada, which I know to be false.

17. I did not accept Soltani's allegations as true. I depose to them only as statements I observed Soltani making in the context of seeking to cancel Mr. Dalton's participation.

18. In the Summer of 2023, I was personally present at at least one Wakuppers meeting at which **Arezou Soltani** pushed for the cancellation of Mr. Dalton's speech on the basis of the allegations described above, and **Mehdi Ahmadzadeh** endorsed Soltani's position at that meeting.

19. I attended that Wakuppers meeting for the purpose of providing advice to the group. At that meeting, I opposed Soltani's position and the demand that Mr. Dalton's participation be cancelled, and I stated that cancelling his speech on the basis advanced by Soltani was improper and harmful to the event and its objectives.

#### **F. Instagram livestream**

20. While at the February 9, 2024 event, I broadcast Mr. Poilievre's remarks live on Instagram (the "Instagram Livestream").

#### **G. Wakuppers native chat exports and reproduced excerpts**

21. I have explained in my earlier affidavits, including **Affidavit #14**, how the Wakuppers group chat exports were obtained and preserved.
22. The native chat exports referred to in this affidavit are among the materials that were provided to me by Dr. Rosita Fatemi, who is a director of the Canadian Iranian Wakuppers Foundation (“Wakuppers”).
23. I have already included the native chat exports, together with certified translations, as part of the materials attached to my Affidavit #14. For convenience, I reproduce below the relevant excerpts from those certified translations, together with the corresponding timestamps and participant display-names as shown in the exports.
24. The relevant excerpts are as follows. In these excerpts, “**Mehdi Stone**” refers to the defendant **Mehdi Ahmadzadeh**, “~ PR” refers to **Pourandokht Rostamian**, “**Mary Doug**” refers to **Mary Hakimi**, and “**Arezou Soltani**” refers to the defendant **Arezou Soltani**:
  - [2024-02-09, 7:47:05 PM] ~ PR: “Friends, Pierre-Poilievre is among Iranians and that bastard Masjoody is there and has gone live. You can go on Instagram, and if that non-human talks, let’s destroy him.”
  - [2024-02-09, 8:36:24 PM] Arezou Soltani: “Does anyone know the restaurant?”
  - [2024-02-09, 8:43:56 PM] Farzane Naroue: “Dear Arezou, what happened with tomorrow’s program?”
  - [2024-02-09, 9:02:03 PM] Hossein Delshad: “It’s the Islamic Republic’s trick.”
  - [2024-02-09, 9:40:51 PM] ~ PR: “Exactly.”
  - [2024-02-10, 12:25:19 AM] Mehdi Stone: “Further details tomorrow.”
  - [2024-02-10, 1:25:15 AM] Mehdi Stone: “What an eventful night we had” (with celebratory emojis)
  - [2024-02-10, 1:28:55 AM] Arezou Soltani: “Fruitful.” (with celebratory emoji)
  - [2024-02-10, 1:31:09 AM] Arezou Soltani: “Dance so we dance; fight so we fight.”

- [2024-02-10, 6:56:35 PM] Mary Doug: “We must annihilate this dishonourable Masjoody.”

25. I rely on these excerpts to show that participants were discussing my Instagram livestream and the Poilievre event in real time, that Arezou Soltani asked about the restaurant/venue, that certain participants expressed hostile and violent intent toward me, and that Soltani and Ahmadzadeh celebrated the outcome described below.

#### **H. Identity of “Mary Doug” and relationship with Doug Horne (as known to me)**

26. In the Wakuppers chat exports, one participant appears under the display-name “**Mary Doug.**” I know that this participant is **Mary Hakimi**.

27. At the time of the messages reproduced above, I knew Mary Hakimi to be the girlfriend (or partner) of **Doug Horne**, a former Conservative MLA.

28. Mary Hakimi is significantly younger than Mr. Horne; to my observation, she appeared to be approximately about half his age.

29. I am aware that Mary Hakimi has stated on multiple occasions words to the effect that, through her relationship with Mr. Horne, she could **damage or destroy the reputation** of individuals within Conservative Party circles, including by portraying them as **MEK supporters**.

30. Based on my experience in Iranian diaspora advocacy and political organizing, I have observed that the **Islamic Republic of Iran** and networks aligned with it sometimes seek to advance their agenda in foreign nations by cultivating **personal intimacy and social access** to influential individuals and communities, and by using **smear tactics** against Iranian opposition figures. Such tactics are sometimes described colloquially as “**honey-trap**” tactics. In particular, I have observed that accusations and labelling relating to the **MEK** are frequently deployed as a tool to discredit, divide, and marginalize Iranian opposition voices in diaspora political spaces.

#### **I. Arrival of individuals I identified as Hamas supporters (February 9, 2024)**


31. On February 9, 2024, shortly after the Honourable Pierre Poilievre’s remarks that I livestreamed on Instagram, and shortly after the commencement of Wakuppers group

chat discussions described above, additional individuals arrived in and around the event area.

32. Based on what I observed and heard at the scene, I identified at least some of those individuals as supporters of Hamas, including because they were chanting slogans associated with Hamas and its supporters, and because some were wearing keffiyehs and displaying other symbols associated with Hamas-aligned activism.
33. Those individuals engaged in disruptive conduct, including shouting/chanting at attendees and the speaker, verbal harassment, and pushing.
34. As a result of the disruption, the event was shut down, and the Honourable Pierre Poilievre was escorted out and could not finish his remarks.
